- (4) at least one member from the community who has no affiliation with the institution<sup>C</sup>
- (5) at least one member whose specialty is non-scientific (may be one of the members from groups 2-4)<sup>N</sup>
- (6) at least one member knowledgeable in therapeutic natural health products<sup>H</sup> (ad hoc for review of therapeutic natural health products)<sup>H</sup>
