## Results Notification - Follow-up Needed

You are receiving this letter because you recently completed an at-home fecal immunochemical test (FIT).

The result of your test shows that further follow-up is needed. The recommendation is for you to have a colonoscopy assessment.

Follow-up for a colon screening result is common and does not mean that you have cancer – about 10 per cent of people that complete a FIT will require further follow-up. However, it is important that you attend all follow-up appointments.

**NEXT STEPS**: Your local health authority will contact you to schedule follow-up. Follow-up is usually a colonoscopy. It may take some time for staff to contact you. To check current wait times for your area, please call XXX-XXX-XXXX.
